TERMS & CONDITIONS

1.0 ORGANISER & ELIGIBILITY

- The ChipsMore! Pet Chunk Contest ("the Contest") is organised by Mondelez

 (536551-W)] ("the Organiser") and is open to all legal residents of Malaysia aged
 18 years and above as of the start of the Contest Date, 1 February 2025.
- 2. The following group of persons shall not be eligible to participate in the Contest:
 - Employees of the Organiser (including its affiliated and related companies)
 and their immediate family members (children, parents, brothers and
 sisters, including spouses); and
 - Representatives, employees, servants and/or agents of advertising and/or Contest service providers of the Organiser (including its affiliated and related companies), and their immediate family members (children, parents, brothers and sisters, including spouses).

 - b. Latest submission of entry will be by 20:00 PM on 31 March 2025. Any submissions received after 31 March 2025 will not be accepted or entertained for any reason whatsoever. All receipts dated must be within the Contest Period.

3.0 SUBMISSION & QUALIFYING CRITERIA

1. To play the Game:

 shower, style and play.
- 2. Purchase RM5.00 or more of any ChipsMore product in a single receipt, then upload a photo of your receipt to earn points and stay at the top of the leaderboard for a chance to win prizes.
- 2. The criteria for a valid receipt are as follows:
 - 1. Store name and/or logo printed on the receipt.
 - 2. Any purchase of ChipsMore with a valid purchase amount stated clearly.
 - Date printed on receipt must be within the Contest Period, 1 February 31
